 - there will be no appeal whatsoever from any decision of the Board in relation to a review of your handicap
- A member may resign from membership of the club only if the member has:
 - paid all amounts owing by the member to the club, and
 - given not less than one month's written notice to the General Manager. Otherwise, the member will continue to be a member and liable for any outstanding membership fees and other amounts payable to the Club.
- Wollongong Golf Club is subject to the provisions of the Privacy Act 1988 (Cwth). The personal information you provide when you join the Club is used to maintain your membership of the Club and to comply with the Registered Clubs Act 1976, the Corporations Act (Cwth) 2001 and the Club's constitution.
